3. Item of Review/Discussion: Mayor Randall Walker

3a. Department of Community Development

1. Consider options relative to South Street right-of-way:
Mr. Wood brought up a discussion relative to South Street right-of-way options for Council's consideration. The potential owner submitted a plan in reference to the restaurant size and parking. The owner asked if the City would consider overflow parking on the South Street right-of-way as an alternate to Mr. Wood's plan relative to the parking issues. Mr. Wood stated Mr. Gilmour suggested shifting the retention pond to accommodate additional parking.

Mr. Wood informed Council the utilities are located in a portion of South Street right-of-way. He also advised there is an undeveloped parcel

directly across from South Street that needs to remain accessible. The driveway is recommended to be developed as a City Street.

Mr. Gilmour recommended Council approve Mr. Wood's plan.

Council concurred to move forward with Mr. Wood's recommendation for review.

2. <u>Naming of building:</u> Mr. Wood recommended to Council to name Community Development building "Planning, Engineering & Building Services", as suggested by Council Member Peterson.

Council concurred to name the building "Planning, Engineering & Building Services".

3b. Presentation(s):

1. <u>Presentation the City's WaterFirst program:</u> Mr. Smith conducted a presentation regarding the City's WaterFirst program. The program will provide the citizens of Perry with better water services. The City of Perry is committed to water stewardship, growth management, quality of life, long-range planning, state collaboration, and superior service.

Council Member Jones and Mayor Pro-Tempore King congratulated Mr. Smith for a presentation well done.

Mayor Walker stated that Mr. Smith's presentation was very well received by the review panel. The City was selected as a WaterFirst community.

Mayor Walker also thanked Public Works for their hard work.

3c. <u>Department of Public Works</u>

1. <u>Rozar Park Culvert Repair</u>: Ms. Fitzner presented to Council a proposal for contract services to repair a pipe located at Rozar Park. The cost of the repair is \$41,221.00.

Administration recommended Council concur with Ms. Fitzner's repair proposal.

Council concurred to approve the proposal, for Rozar Park Culvert repair.

3d. Department of Leisure Services

Consider offering a modified youth basketball program:
 Mr. Swan proposed to Council a modified youth basketball program due to COVID-19 restrictions and health concerns.

Mr. Swan proposal to Council included the following proposed solutions:

- Adhere to the guidelines provided by the CDC and GHSA
- Adjust operations
- Video streaming

Mayor Walker asked if there had been any discussions with the high schools relative to the practicing and utilizing how they are going to require the City to clean their facilities. Mr. Swan responded that the school system has been restricting access to any outside institute. Their goal was to continue using their facilities for practice through the rest of the year.

Administration is not recommending the program due to COVID-19 restrictions and a new Executive Order from the government. Administration is recommending cancelling the program until further notice.

Mayor Walker supported Administration's decision.

Council concurred after a long discussion regarding costs, restrictions and safety concerns for participants to allow Mr. Swan to proceed with the program with the following conditions: 1) Program players must follow the CDC and GHSA guidelines, 2) no video streaming, and 3) strict adherence to adjusted operations. Council Members Jones and Hunt were not in agreement.

Staff Report: Mr. Gilmour stated that this request is to authorize the sale of Beer and Wine only at Schultze's Old Fashioned Soda Shop located at 757 Carroll Street, the location is in the restaurant district and adjacent to Calvary Way Community Church.

<u>Public Input:</u> Mayor Randall Walker called for any public input for or against the petition.

<u>For:</u> Ms. Lauren Shultz stated that she and her husband are the business owner of Shultze's Old Fashioned Soda Shop and is asking for approval of the request. Ms. Shultz stated that because her business is in the restaurant district by State Law, she can serve alcohol, even if she is next door to a church. Ms. Schultz stated that she just wants her business to thrive and to serve the community.

Against:

- Mr. Greg Sutton, 126 Arena Road, Perry Member of Calvary Way Community Church, stated he is against the request for Schultze's business alcohol license because of the business being next door to his Church.
- Larry Albritton, 1407 Canterbury Ct, Perry- Pastor of Calvary Way Community Church spoke against the request for the alcohol license for a business that is adjacent to the church. Mr. Albritton's biggest concern is for his congregation's safety and the prosperity of the church. Mr. Albritton also stated that his church currently has to deal with picking up litter i.e cigarette butts, it would increase if the Council approves the request.
- Tracy Brinson, Lake Joy Road Member of Calvary Way Community Church, stated if the Council approves this request, it could set a precedent for other churches, no one would want a business that sells alcohol next to their home.
- Melissa Powell, 181 Solomon Road, Perry-Community Church, stated that her fear is for the kids walking to Church seeing and being exposed to people who drink and curse.

- Patty Callahan, 115 Forest Ave, Bonaire Member of Calvary Way Community Church, stated that she wants her Church to be safe and worries about the mindset of individuals who drink.
- Brandon Lynch 229 Sentry Oaks Dr., WR- Member of Calvary Way Community Church, stated if the alcohol license is approved it would shift the atmosphere surrounding the church and is asking the Mayor and Council to deny the request.
- Don Chandler, Oglethorpe Member of Calvary Way Community Church, asked that Mayor and Council do the right thing for the community and deny the request.
- Philip Rice, 1424 Elizabeth Ave, Perry- Member of Calvary Way
 Community Church, stated that he is a recovering addict and if it wasn't
 for his church he would not be the person he is today. Asks Council to
 deny this request.
- Juanita Kirby, 901 Perimeter Road, Perry-Member of Calvary Way Community Church stated that she is concerned for the safety of the church congregation and anyone leaving the business inebriated and causing accidents.
- Harry Kirby, 901 Perimeter Road, Perry-Member of Calvary Way
 Community Church stated he agrees with all of his parishioners that the
 request should be denied and trust Mayor and Council to make the right
 decision.

AN ORDINANCE OF THE COUNCIL OF THE CITY OF PERRY, GEORGIA, CHAPTER 2, <u>ADMINISTRATION</u>; REPEALING DIVISION 4 OF ARTICLE V, <u>PERRY PUBLIC ARTS COMMISSION</u>; TO REPEAL ALL CODE PROVISIONS, ORDINANCES, OR PARTS THEREOF, IN CONFLICT HEREWITH; AND TO AMEND SECTION 2-252 OF DIVISION 5 OF ARTICLE V, <u>MAIN STREET ADVISORY BOARD</u>, ACCORDINGLY RELATIVE TO APPOINTMENT OF MEMBERS TO THE MAIN STREET ADVISORY BOARD

THE COUNCIL OF THE CITY OF PERRY HEREBY ORDAINS that the Perry Code is amended as follows:

1.

The Code of Ordinances is hereby amended by repealing, in its entirety, Division 4-Perry Public Arts Commission of Article V, Chapter 2. Sections 2-241 through 2-248 are hereby reserved.

2.

The Code of Ordinances is hereby further amended by replacing Section 2-252-Members, of Division 5-Main Street Advisory Board, of Article V, Chapter 2, to read as follows:

Sec. 2-252. - Members.

- (a) The Main Street Advisory Board shall consist of seven (7) members. All seven (7) members of the board shall be at least eighteen (18) years of age and either a resident of the Perry service area, owner of property in the downtown district, or owner or manager of a business in the downtown district.
- (b) The mayor and council shall appoint seven (7) members to the board. Two (2) of the initial members of the board shall be appointed for a one-year term, two (2) shall be appointed for a two-year term and three (3) shall be appointed for a three-year term. Thereafter, all members appointed shall serve for a three-year term.
- (c) The members shall be appointed by and serve at the pleasure of the mayor and council. Vacancies caused by death, resignation or otherwise shall be filled for the unexpired term by the mayor and council.
- (d) Any member of the board can be removed by two-third (2/3) vote of the mayor and council, with the mayor having the right to vote on the question of removal. Absence from three (3) meetings within a calendar year without justification may be cause for removal from the board.
- (e) All members of the Main Street Advisory Board shall serve without compensation; provided, however, the city council may reimburse board members for reasonable expenses incurred in connection with their service as board members.

BE IT FURTHER ORDAINED that all ordinances and Code sections, or parts thereof, in conflict with the foregoing are expressly repealed.

AN ORDINANCE TO AMEND THE CHARTER OF THE CITY OF PERRY, GEORGIA BY ADDING A NEW SECTION IMMEDIATELY FOLLOWING SECTION 1.15, TO BE DESIGNATED AS SECTION 1.16, SO AS TO PROVIDE FOR ADDITIONAL POWERS, DUTIES, AND AUTHORITY OF THE CITY COUNCIL OF THE CITY OF PERRY, GEORGIA WITH RESPECT TO A JOINT UTILITY COMMISSION; TO REPEAL ALL OTHER ACTS AND ORDINANCES IN CONFLICT HEREWITH; AND FOR OTHER PURPOSES.

WHEREAS, the City of PERRY, Georgia, a municipal corporation of the State of Georgia (the "City"), operates pursuant to the Constitution and laws of the State of Georgia and its Charter, approved March 29, 1983, as amended; and

WHEREAS, the City has now determined that it is necessary to make certain amendments to its Charter pursuant to its home rule powers granted pursuant to Article IX, Section II, Paragraph II of the Constitution of the State of Georgia and O.C.G.A. Section 36-35-1 through 36-35-7; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Perry, Georgia, and IT IS HEREBY ORDAINED, by the authority of the same, as follows:

Section 1. The Charter of the City of PERRY, Georgia, which was established by an Act creating a new Charter for the City of PERRY, Georgia, approved on March 29, 1983, as amended, is hereby amended by adding a new section to read as follows:

SECTION 1.16. Title. This may be cited as the "Mid-State Energy Commission Act."

- (a) Definitions.
- (1) The word "Cities" means, collectively, the City of Byron, Georgia, the City of Cochran, Georgia, the City of Hawkinsville, Georgia, the City of Perry, Georgia, and the City of Warner Robins, Georgia.
- (2) The word "Commission" means the Mid-State Energy Commission created by subsection (c) of this act.
- (3) The word "JONG" means Jointly Owned Natural Gas, a partnership created by written agreement between the City of Cochran, Georgia, the City of Hawkinsville, Georgia, the City of Perry, Georgia, and the City of Warner Robins, Georgia on or about January 15, 1953, as amended from time to time.
- (4) The word "project" means all "undertakings" under the Revenue Bond Law, including without limitation, the acquisition and construction of all necessary and usual facilities for the obtaining of one or more sources of natural gas supply and the distribution and sale of natural gas to users and consumers, including counties and municipalities for the purpose of resale, inside and outside the territorial boundaries of the Cities and the operation, maintenance, additions, improvements, and extensions of such facilities so as to assure an adequate natural gas utility system deemed by the Commission necessary or convenient for the efficient operation of such type of undertaking.
- (5) The terms "revenue bonds" and "bonds," as used in this act, means revenue bonds as defined and provided for in Article 3 of Chapter 82 of Title 36 of the O.C.G.A., known as the "Revenue Bond Law," as amended, and such type of obligations may be issued by the Commission

- as authorized under the "Revenue Bond Law" and, in addition, shall also mean obligations of the Commission, the issuance of which are hereinafter specifically provided for in this act.
- (6) The word "service area" means any area within or without the Cities, includes without limitation, the area served jointly by the Cities or by JONG, and all other areas to the extent such areas are not currently served by another gas utility.
- (b) Purpose of Commission. Without limiting the generality of any provisions of this act, the general purpose of the Commission is declared to be that of effecting efficient intergovernmental projects among the Cities, including, without limitation, acquiring an adequate source or sources of natural gas and thereafter the distribution of same to the natural gas systems of current and future customers; but such general purpose shall not restrict the Commission from selling and delivering natural gas directly to consumers in those areas where neither any county nor any municipality deems it desirable or feasible to furnish natural gas; nor shall it restrict the Commission from selling and delivering natural gas to counties which do not adjoin the Cities or to municipalities located therein. The Commission is intended to replace JONG as its successor-in-interest.
- (c) Commission created; members; terms; eligibility; officers; quorum; compensation.
- (1) There is hereby created a body corporate and politic to be known as the Mid-State Energy Commission which shall be deemed to be a political subdivision of the State of Georgia and a public corporation and by that name, style, and title, said body may contract and be contracted with, sue and be sued, implead and be impleaded, complain and defend in all courts of law and equity. The Commission shall be deemed a subordinate entity of each and all of the Cities.
- (2) The Commission shall consist of five (5) members who shall be determined and selected as follows:
- (a) One member shall be the Mayor or a person appointed by the Mayor of the City of Byron, Georgia;
- (b) One member shall be the Mayor or a person appointed by the Mayor of the City of Cochran, Georgia;
- (c) One member shall be a person appointed by the City Commission of the City of Hawkinsville, Georgia;
- (d) One member shall be the Mayor or a person appointed by the Mayor of the City of Perry, Georgia;
- (e) One member shall be the Mayor or a person appointed by the Mayor of the City of Warner Robins, Georgia.
- (3) The members shall serve at the pleasure of the respective appointing Mayor or City Commission and each Mayor or City Commission shall have the right and authority to remove any member from the Commission and to appoint replacements as may be required to fill vacancies.
- (4) No person shall hold the office of Commission member if that person is ineligible for such office pursuant to O.C.G.A. § 45-2-1 or any other general law.

- (5) The Commission shall elect one of its members as chairman and another as vice chairman. The Commission may also select a secretary and treasurer, who need not necessarily be members of the Commission. Three (3) members of the Commission shall constitute a quorum. No vacancy on the Commission shall impair the right of the quorum to exercise all the rights and perform all the duties of the Commission.
- (6) The members of the Commission shall each be entitled to compensation for their services at a rate periodically reviewed and set by the Commission, payable monthly. All such compensation payable by the Commission shall be in addition to any compensation otherwise payable to any member of the Commission by any municipality or county by virtue of any municipal or county elective office held by such member. All members shall be reimbursed for their actual expenses necessarily incurred in the performance of their duties. No reimbursement or payment shall be made by the Commission for travel, meal, or entertainment expenses for members of the Commission unless on each occasion the incurring of such expenses for the same are approved in advance by the Commission at one of its public meetings. The Commission shall have perpetual existence.
- (d) General powers.
- (1) The Commission shall have all powers necessary or convenient to carry out and effectuate the purpose and provisions of this article including, but without limiting the generality of the foregoing, the power:
 - (a) to have a seal and alter the same at pleasure;
- (b) to acquire by purchase, lease or otherwise, and to hold, lease and dispose of real and personal property of every kind and character for its corporate purposes;
- [to acquire in its own name by purchase, on such terms and conditions and in such manner as it may deem proper, or by condemnation in accordance with the provisions of any and all existing laws applicable to the condemnation of property for public use, real property or rights of easements therein or franchises necessary or convenient for its corporate purposes, and to use the same so long as its corporate existence shall continue and to lease or make contracts with respect to the use of or dispose of the same in any manner it deems to the best advantage of the Commission, the Commission being under no obligation to accept and pay for any property condemned under this act except from the funds provided under the Commission of this act, and in any proceedings to condemn, such orders may be made by the court having jurisdiction of the suit, action or proceedings as may be just to the Commission and to the owners of the property to be condemned, and no property shall be acquired under the provisions of this act on which any lien or other incumbrance exists, unless at the time such property is so acquired a sufficient sum of money be deposited in trust to pay and redeem the fair value of such lien or incumbrance; and if the Commission shall deem it expedient to construct any project on any other lands the title to which shall then be in the State of Georgia, the governor is hereby authorized to convey, for and in behalf of the state title to such lands to the Commission upon payment to the state treasurer for the credit of the general fund of the state of the reasonable value of

such lands, such value to be determined by three (3) appraisers to be agreed upon by the governor and the chairman of the Commission;]

- (d) to appoint, select and employ, officers, agents and employees, including engineering, architectural and construction experts, fiscal agents and attorneys, and fix their respective compensations;
- (e) to make contracts, leases and to execute all instruments necessary or convenient, including contracts for construction of projects and leases of projects or contracts with respect to the use of projects which it causes to be erected or acquired, and any and all persons, firms and corporations and any and all political subdivisions, departments, institutions or agencies of the state are hereby authorized to enter into contracts, leases or agreements with the Commission upon such terms and for such purposes as they deem advisable; and without limiting the generality of the above, authority is specifically granted to municipal corporations and counties and to the Commission to enter into contracts, lease agreements, or other undertakings relative to the furnishing of natural gas and related services and facilities by the Commission to such municipal corporations and counties for a term not exceeding 50 years, including, but not limited to, the operation and maintenance of natural gas systems owned by the Cities;
- (f) to construct, erect, acquire, own, repair, remodel, maintain, add to, extend, improve, equip, operate and manage projects, as hereinabove defined; the cost of any such project to be paid in whole or in part from [the proceeds of revenue bonds of the Commission or from] such proceeds and any grant from the United States of America or any agency or instrumentality thereof;
- (g) to accept loans and/or grants of money or materials or property of any kind from the United States of America or any agency or instrumentality thereof, upon such terms and conditions as the United States of America or such agency or instrumentality may impose;
- (h) [to borrow money for any of its corporate purposes and to issue negotiable revenue bonds payable solely from funds pledged for that purpose, and to provide for the payment of the same and for the rights of the holders thereof;]
- (i) to exercise any power usually possessed by private corporations performing similar functions, which is not in conflict with the constitution and laws of this state; and
- (j) to do all things necessary or convenient to carry out the powers expressly given in this act.
- (e) Conversion from JONG.
- (1) Without limiting the foregoing in any way, the Commission shall have all the powers formerly delegated to JONG by the Cities.
- (2) The Cities hereby delegate to the Commission all power to construct, erect, acquire, own, repair, remodel, maintain, add to, extend, improve, equip, operate and manage any real or personal property owned by JONG.
- (3) The Cities shall prescribe rules and regulations for the operation of the Commission by intergovernmental agreement.
- (f) Rates, charges and revenues; use. The Commission is hereby authorized to prescribe and fix and collect rates, fees, tolls or charges,

and to revise from time to time and collect such rates, fees, tolls or charges for the services, facilities or commodities furnished[, and in anticipation of the collection of the revenues of such undertaking or project, to issue revenue bonds as herein provided to finance in whole or in part the cost of the acquisition, construction, reconstruction, improvement, betterment or extension of the natural gas utility system, and to pledge to the punctual payment of said bonds and interest thereon, all or any part of the revenues of such undertaking or project, including the revenues of improvements, betterments or extensions thereto thereafter made.]

- (g) Tax exempt status. The properties of the Commission, both real and personal, are declared to be public properties used for the benefit and welfare of the people of the State of Georgia, and not for purposes of private or corporate benefit and income, and such properties and the Commission shall be exempt from all taxes and special assessments of any city, county, or the state or any political subdivision thereof.
- (h) Liberal construction of act. This act, being for the welfare of various political subdivisions of the state and its inhabitants, shall be liberally construed to affect the purposes hereof.
- (i) Effect of partial invalidity of act. The provisions of this act are severable, and if any of its provisions shall be held unconstitutional by any court of competent jurisdiction, the decision of such court shall not affect or impair any of the remaining provisions.
- (i) The Commission, or any Commission or body which had or which may in the future succeed to the powers, duties and liabilities vested in the Commission created hereby, shall have power and is hereby authorized at one time, or from time to time, to provide by resolution for the issuance of negotiable revenue bonds in a sum determined by the Commission for each issuance and a total sum for cumulative issuances outstanding at any one time of the Commission for the purpose of paying all or any part of the cost as herein defined of any one or more projects. The principal and interest of such revenue bonds shall be payable solely from the special fund herein provided for such payment. The bonds of each issue shall be dated, shall bear interest at such rate or rates not exceeding the interest allowed by the Revenue Bond Law as now provided or may hereinafter be provided by amendment thereto, payable semi-annually, shall mature at such time or times not exceeding 40 years from their date or dates, shall be payable in such medium of payment as to both principal and interest as may be determined by the Commission, and may be made redeemable before maturity, at the option of the Commission, at such price or prices and under such terms and conditions as may be fixed by the Commission in the resolution providing for the issuance of the bonds.

Section 2. All portions of the Charter or amendments thereto or all ordinances in conflict herewith be and the same are hereby repealed.

Section 3. If any part of this ordinance shall be declared void, it is the intent and the purpose hereof that all other provisions not so declared void shall remain in full force and effect.

Section 4. The Clerk of the City is hereby authorized and directed to cause a notice, a copy of which is attached hereto as Exhibit "A" and hereby incorporated by reference, to be published in the Houston Home Journal, the official newspaper in which Sheriff's advertisements are published in Houston County, in which the City is located, once a week for three weeks within a period of sixty days immediately preceding the day of the final adoption of this ordinance. The Clerk of the City is also hereby authorized and directed to cause the publisher of the Houston Home Journal to execute an affidavit of such publication.

This ordinance was introduced and read at a lawful meeting of the Council of the City of Perry, held on November 3, 2020 and read the second time, passed, and adopted in like meeting held on November 17, 2020.

INTERGOVERNMENTAL AGREEMENT FOR THE EMERGENCY USE OF COUNTY FUEL SUPPLY BY THE CITY OF PERRY

THIS AGREEMENT, made this _____ day of _______, 2020, is by and between THE BOARD OF COMMISSIONERS OF HOUSTON COUNTY on behalf of Houston County, Georgia (hereinafter "County") and THE MAYOR AND COUNCIL OF THE CITY OF PERRY on behalf of the City of Perry (hereinafter "City").

WHEREAS, the City and the County recognize an increasing possibility of the occurrence of emergencies or disasters resulting from manmade or natural causes or enemy attack that could disrupt the commercial fuel supply system the City relies on in its day to day operation; in order to ensure that preparation and response will be adequate to deal with such emergencies and protect the public peace, health, and safety; and to preserve lives and property, it is found and declared to be necessary that both parties enter into this Agreement in order for the County to provide emergency fuel assistance to the City:

NOW, THEREFORE, in consideration of the promises, covenants, agreements and stipulations herein set forth and other good and valuable consideration, the parties do hereby agree as follows:

1.

It is the express intent of the parties in executing this Agreement that the County shall provide the City emergency fuel assistance only in the event of a genuine major disaster that disrupts the commercial fuel supply system.

2.

The parties agree that it is not the intent of this Agreement to provide routine fuel support.

3.

The County upon request of the City shall provide the City access to the County fuel supply system at the rate of the cost of fuel plus one percent (1%).

4.

Each party waives all claims against the other for any loss, damage, personal injury, or death occurring as a consequence of the performance of this Agreement.

This Agreement shall remain in force until October 20, 2022. Subsequent Agreements may be made for periods not to exceed two (2) years upon the approval of the City and the County. Either party may terminate this Agreement with thirty (30) days written notice to the other. This Agreement may be altered or modified by amendment thereto provided any amendment must be in writing signed by both Parties.
