### **Job Summary:**

Part time role that responsible for general maintenance, operations, logistics, and administrative support of Leisure Services programs and facilities. The individual selected for this vacancy will be responsible for the performance of duties at the Creekwood Park Splash Pad for the duration of the operating season, which generally runs from late-May to early-September, weather dependent.

- Open and close the splash pad as scheduled.
- Greet, interact, and communicate with the diverse population in a fair, consistent, and professional manner.

- Opens and closes the splash pad as scheduled.
- Assists customers, program participants, and volunteers during program activities, ensuring proper conduct and appropriate use of the facilities and grounds.
- Monitors and assists rental groups (i.e., for pavilion and other facilities/fields).
- Maintains Leisure Services facilities in accordance with Department standards; monitors and cleans restrooms and grounds as needed.
- Assists with maintaining records, logs, of all chemical testing at aquatic facility and keep compliance with Health Dept.
