Media Release

On February 10, 2021, the Houston County Sheriff's Office and the Perry Police Department executed multiple search warrants at locations within Houston County, Georgia in reference to an ongoing narcotics investigation. Search warrants were executed at 111 Northeast Drive, Warner Robins, Houston County, Georgia 31093, 124 Red Fox Run, Warner Robins, Houston County, Georgia 31088, and three (3) separate storage units at various self-storage complexes in Warner Robins, Houston County, Georgia.

During the search of the locations, investigators seized over two (2) kilograms of methamphetamine, marijuana, Xanax tablets, three (3) firearms, and an amount of US currency.

The following subjects were arrested and charged as part of this investigation:
